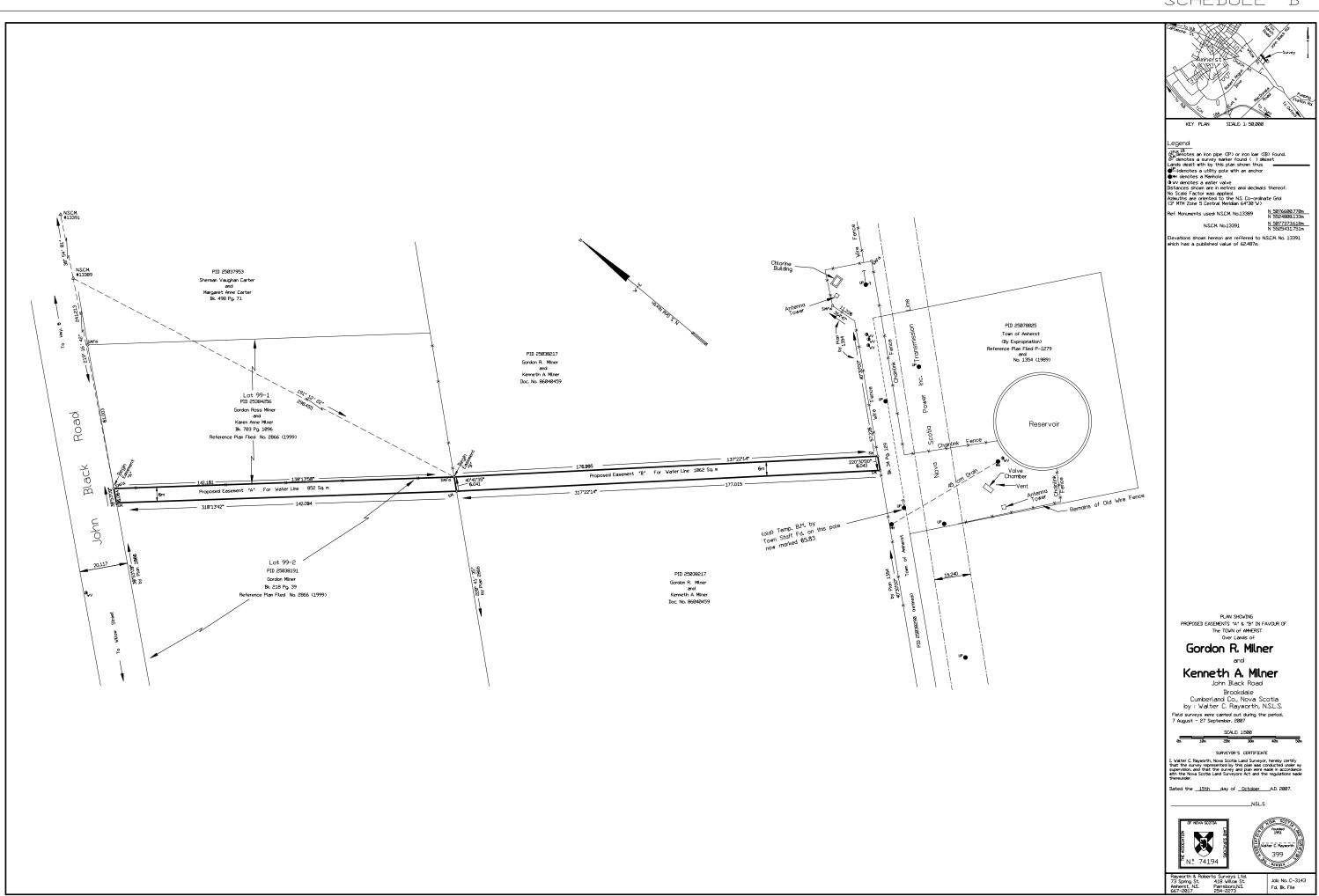

TOWN OF AMHERST USER FEE POLICY #3470-03

PURPOSE:

To establish a schedule of user fees for Council to review for appropriateness and to revise if necessary during the annual budgeting process.

POLICY STATEMENT:

It is appropriate for Council to charge fees, as authorized under the Municipal Government Act, in the Town's Bylaws, Policies and Procedures in order to defray its administrative costs. In order to allow for a systematic and thorough evaluation of those fees, a comprehensive schedule of User Fees with applicable tax status has been established. The responsibility for the accuracy of Schedule shall rest with the department to which a fee applies. Any additions/deletions to the Schedule will be updated by the Executive Office. Those fees legislated under Provincial and/or Federal Acts and Authorities will also be shown on the schedules for completeness, but will not be subject to change by Council.

OBJECTIVES:

To make the administration of the cost recovery portion of the Town's Bylaws, Policies and Procedures more efficient and to determine the impact on each year's projected revenues during the budget process. By combining all of the fees in one document, the review will be more visible and complete.

2. <u>Public Fire Protection Service</u>

The Town of Amherst shall pay, annually, to the Water Utility in monthly installments for fire protection services, on or before September 30, 2007, the amount of \$413,088.

3. Rates for Sprinkler Service

Each building having a sprinkler system installed shall pay annually for the service as follows:

 Each building serviced by a sprinkler service pipe of 6" or less in diameter

Each building serviced by a sprinkler service pipe of

8" or more in diameter \$250.00

4. Water Rates for Buildings or Works Under Construction

The Utility may furnish water to any person requiring a supply thereof for the construction of a building or other works. This person shall deposit with the Utility such sum as may be determined by the Utility as is sufficient to defray the cost of making the necessary connection to any water service or main, together with the cost of the meter to be installed to measure the water consumed. Upon completion of the work and the return of the meter to the Utility, a refund will be made after deducting the cost, if any, of repairing the meter and of testing the same and payment of the base and connection charges and the consumption rates in respect to such installations.

5. Rates for Water Supplied from Fire Hydrants

Whenever the use of any fire hydrant is desired to supplying water for any purpose, excepting those of the Fire Department for fire use, the Utility may grant a permit containing such terms and conditions as it may provide, including arrangements regarding supervision of the opening and closing of the hydrant, and a service charge for commercial consumers of \$60.00 for connection and disconnection and a consumption charge for the amount of water used, as estimated by the Utility, at meter consumption rates.

6. Private Hydrant Rates

Per hydrant per year \$175.00

7. Charges for Re-establishing Water Service

When water service has been suspended for any violation of the Rules and Regulations of the Utility, such water service shall not be re-established until a reconnection charge of \$25.00 has been paid to the Utility.

8. Connection Fee

The Utility shall charge a \$25.00 fee for the creation of a water account, notwithstanding the fact that no physical disconnection of the system may have occurred. This fee shall be \$200.00 if water is turned on after normal working hours of the Utility.

9. <u>Charge for Non-Negotiable Cheques</u>

The Utility shall charge a \$15.00 administration fee for cheques that, due to non-negotiability, have been rejected by the Utility's bank.

10. <u>Charge for Missed Appointment by Customers</u>

Where an appointment has been made by a customer to have a water service hooked up or a meter inspected, or water turned on to a property, or other visits to the property for the inception or maintenance of water service to the property, and the customer fails to keep the appointment or the plumbing is not completed to allow for installation of a water meter and the Utility's staff have to return to the property, there may be a charge of \$25.00 for each visit if, in the judgment of the Utility, it is required.

11. Rates for Bulk Water

Bulk water will be provided to licensed water haulers at designated locations at a cost of \$2.25 per cubic meter or part thereof.

The YMCA agrees to provide the following services to the Town:

- 1. Commencing on or about Friday, October 19, 2007 and continuing for an aggregate of 32 weeks concluding in June 2008, the YMCA will facilitate a Youth and Teen Night on each Friday. The time allotted for this activity will be for 6:30 PM to 10:00 PM and will include various structured gym or athletic activities, arts, crafts, videos and at least one full hour dedicated for a recreational swim program. This program will host a maximum of 50 youth/teens each night with a nominal charge of not more than \$2.00 being charged with the proceeds being used by the YMCA to defer some of its operating costs. This program will include the costs related to lifeguards, program staff, equipment, uniforms, supplies and all other costs related to the operation of a successful youth and teen program.
- 2. The YMCA agrees and undertakes with the Town:
 - a) To provide for a well maintained pool and recreation facility and employ responsible policies and procedures in the day to day operation of its facilities.
 - b) To supervise the pool in accordance to generally accepted standards with lifeguards appropriately qualified under the National Lifeguard Service and qualified in First Aid.
 - c) To ensure that lifeguards are supervised and coordinated by the YMCA's Aquatics Director at all times and that program staff are supervised and coordinated by the YMCA's Program Director.
 - To collect statistical information related to the attendance, participation and residency of youth attending this program.
 - e) To indemnify the Town from liabilities, damages, costs, claims, suits or actions resulting from:

This year's capital paving is nearing completion with only Rogers Avenue remaining. Costin Paving will re-grade the street, do a final compaction and then pave the street with a 1.5" thick base coat of asphalt. The final 1.5" finish coat of asphalt will be placed in early summer 2008.

R.B. Summerville Construction will commence installation of 2km of new natural gas mains and approximately 25 new building services. Our staff have been busy issuing water and sewer clearances for this work.

We would like to remind residents that the special two week fall leaf and yard waste collection will begin November 5th. Leaves must be placed in clear bags while brush and branches that will not fit in the compost bin should be bundled for pick up.

Work done at the stadium this summer involving the new slab, new mechanical system, new boards and glass and the new roof are all substantially complete with only a few deficiencies remaining.

The work under Phase III of the renovations in on-going now with demolition work complete, foundation work substantially complete, while structural steel erection and masonry installation is underway. Staff are busy coordinating construction activities as they arise from our contractor Flagship Construction, or our Architect, Arthur J. Arsenault Architects of Sackville. It appears that the building will be enclosed by early December with construction work substantially complete by late January.

During this construction phase we have provided temporary building access to the Stadium on the north side. We would like to thank stadium users and patrons for their patience during this phase. This Council's goal for the Stadium has been to have a totally renovated energy efficient facility and in just a few more weeks that goal will be met.

6.2 <u>Community & Economic Development Department Monthly Report</u>

Moved by Councillor David March, seconded by Councillor Dale Fawthrop that Council accept the following monthly report from the Community & Economic Development Department.

Facility Operations

Parks operations are currently focused on removal of benches and tables for the parks and preparing for the winter season. Robbs Complex is now closed for the season and nets will be coming down at the tennis courts by the end of this month.

Operations at the Stadium are in full swing with the Amherst Ramblers, Cumberland Minor Hockey Association and Amherst Figure Skating fully scheduled for the coming months. Anyone wanting to book ice time or to get information on advertising opportunities at the Stadium is asked to call 667-6500

During the construction, the front entrance of the Stadium will be closed to the public and access to the building will be from the entrance on the north side of the building. Canteen services will be reduced to the small canteens on the second level. Stadium users have provided excellent cooperation in terms of the inconvenience caused by this construction project and must be applicated.

Residents are reminded that there is a public information display in the lobby of Town Hall which explains and illustrates the work being completed and residents are welcomed to drop in and look at this material and ask any questions they may have.

Community Information Bulletin

Work is completed on the fall and winter 2007 Bulletin and it has been delivered to households in Amherst. We still have a few left so anyone who hasn't received a copy can pick one up either at Town Hall or the Amherst Stadium. It should be noted that we have inserted maps related to the Centennial Trail system in Amherst and directional signage has been posted on the sections of the Trail that is now completed.

Victorian Christmas Light Up

The 5th annual Victorian Christmas Celebration commences on November 16TH with the annual Christmas Light Up celebration at the Victoria Park. Residents are encouraged to participate in the light up and to support the various businesses and organizations that will be holding special "Victorian" themed events throughout the holiday season.

Christmas Parade

The Annual Christmas Parade take place on Saturday, November 17th under the direction once again of the Amherst Y'mens Club. We expect a high level of participation this year once again and expect the entry for the parade will continue to grow. Information related to the both the Parade and Light up celebrations will be posted with the media and will be inserted on the Town of Amherst web site.

Small Business Week

The week of October 15th was Small Business Week in Canada. We would like to congratulate Casey Concrete who has been selected this year by the Chamber of Commerce as Business of the Year. Casey's have been part of Amherst for over 50 years and we applaud the efforts of the Casey family and all their employees. Like Casey Concrete, all our businesses in Amherst work hard to provide quality goods and services as well as provided employment opportunities for our residents. They should be recognized each and every day for their contribution towards our economy and fully supported by our residents.

Wake Up Call

On Wednesday, November 22nd residents are reminded to register for the Wake up Call in memory of Ronnie Elliott who collapsed and died while playing hockey on November 22, 1998. The Wake Up Call is a reminder for each of us to have a yearly medical check up so that you and your family can enjoy life to the fullest. Please support this very worth initiative.

6.3 Planning & Development Department Monthly Report

Moved by Councillor Ed Chitty, seconded by Councillor Terry Rhindress that Council accept the following monthly report from the Planning & Development Department.

Building Activity

As of September 31, 2007 the total value of building permits issued in the Town was \$10,209,4500 compared to \$8,601,367 at this point last year. During the month of September there were 3 new single detached dwellings and one new 4 unit apartment building constructed within the Town. In addition, a new used auto dealership and the final phase of the Amherst Stadium renovations were started.

New_Streets

The Town has taken over a new street named "Matthews Way" off East Pleasant Street. This street was developed by David and Marsha Allen who are constructing 28 townhouse units on the property.

Dangerous and Unsightly Premises

So far this year we have had 17 complaints; seven remain active. During the month of September the Administrator was able to close 8 unsightly files.

Staff have been dealing with the owners of the downtown location of Tim Horton's and Duncan's pub in order to find a more appropriate location for their solid waste disposal bins. We anticipate an agreement in the near future.

Variance Updates

The Development Officer did not issue any variances in the month of September. However Town Council did allow a front yard variance on property located at 43 Clifford Street as a result of an appeal of the Development Officers decision to deny the variance. The variance will result in a one story addition to the front of the house on the property.

Other Items

In light of the decision of Council to allow the front yard variance at 43 Clifford Street the Planning Advisory Committee re-considered the appropriateness of the current 6 metre front yard setback requirement. Upon the recommendation of staff the Committee decided that the 6 metre front yard setback remains appropriate.

6.4 Police Department Monthly Report

Moved by Councillor Robert Angel, seconded by Councillor David March that Council accept the following monthly report from the Amherst Police Department.

Personnel

Cst. Hunter returned to work from Parental Leave on October 15th 2007. A competition in early September identified two new Constables to be hired on a full time basis. Cst. Pierre Lemire from Moncton, who completed his on-job training with our department this summer, and Cst. Jason Galloway of Miramichi, began full time employment during the week of September 17th 2007. A competition held during the week of October 8th identified Cst. Jeremy Kelly of Newfoundland to be hired on a part time basis. A competition to place a member in the newly created position of Staff Sergeant, is ongoing.

Training

All members received training on the use of the ACIIS (Automated Criminal Intelligence Information System). This will allow all members to conduct queries on the system. All members took part in annual firearms qualifications in October. Training was also received for "shooting on the move", "barricade shooting" and "shooting from vehicles", as part of this year's sessions.

Community Officer

Cst. Francis Smith traveled to Toronto in September to attend the National MADD (Mothers Against Drunk Driving) Conference. At the Conference, Cst. Smith was awarded the "Terry Ryan Memorial Award for Excellence in Police Services to recognize the significant contribution in helping to reduce impaired driving. On September 23rd the first annual MADD Candlelight Vigil was held in Amherst, to honor the victims of drinking and driving. Margaret Miller, the National President of MADD Canada was in attendance, along with several local dignitaries. On September 12th Cst. Smith participated in "Code Blue" at E.B. Chandler Jr. High. A practice "lock-down" of the school took place to plan and assess operational procedures in the event of a school emergency. Operation Impact was held on Thanksgiving Weekend. Various checkpoints were conducted, with officers focusing on the wearing of seatbelts, impaired driving and dangerous driving. Stats are unavailable at the time of this report.

N.S. Chiefs of Police Fall Conference

Chief Rushton and D/Chief Naylor attended the Fall Conference of the Nova Scotia Chiefs of Police Association in Truro in late September.

Winter Parking Regulations

We would like to inform the public that Winter Parking Regulations are in effect from November 15th 2007 until April 15th 2008. The Regulations state:

- (a) No owner or driver or person having control or custody of any vehicle, shall between the 15th day of November A.D. 2007 and the 15th day of April A.D. 2008, park or leave standing the same upon any highway or street in the Town of Amherst between the hours of 12:00 o'clock midnight and the hour of 7:00 o'clock in the morning of the same day.
- (b) No owner or driver or person having control or custody of any vehicle shall between the 15th day of November A.D. 2007 and the 15th day of April A.D. 2008, park or leave the same standing and unattended by a person authorized to move or capable of operating the same upon any highway or street in the Town of Amherst in such manner as to hinder, inconvenience or prevent the proper removal of snow or ice from such highway or street.

A fine of \$15.00 will be levied for offences noted.

Councillor Angel thanked Council for the opportunity to serve on the Police commission for the past seven years, as well as on the NSAPB and CAPB. He said he looks forward to working with the Operational Services Department.

6.5 Fire Department Monthly Report

Moved by Councillor Terry Rhindress, seconded by Councillor Dale Fawthrop that Council accept the following monthly report from the Amherst Fire Department:

Alarm Responses

During the reporting period from Sept.7/07- Oct. 10/07 our Fire Department responded to 14 calls in the Town of Amherst and nine calls to the County coverage area. During this period our firefighters responded to four motor vehicle accidents. The calls included structure fires, false alarms, unauthorized controlled burning and four incidents of unattended pots on a stove.

Training & Department Activities

The Fire Department Level One training schedule started on Saturday October 6 with 16 people from several County fire departments signed up for the eight month course. Our new pumper truck is on schedule to arrive the first week in November and the contract for this vehicle includes extensive operational training for the department staff. The Maritime Firefighter Memorial Celebration was held in Amherst on September 30 and was very well attended by Firefighters from across the Atlantic region. We would like to thank those who participated from all areas of government.

Fire Prevention

Three of our fire inspectors, including Chief Crossman attended a five day training course in Yarmouth which covered part four of the National Fire Code that deals with combustible liquids.

Our Fire Prevention program for the month of October will include a special guest speaker from Newfoundland who will be visiting the local schools speaking to the students about the dangers of playing with candles, matches and lighters. He is a burn survivor with a very special story. Our firefighters will also be visiting the schools as well as industry providing fire safety information and helping with their emergency plans.

Recruiting

Our volunteer recruiting program has not been very successful to date, however we are very hopeful that we will still be able to attract at least five new members to our department.

Emergency Measures

We are again reminding residents that it is hurricane season in the Atlantic Region and it will be with us until mid to late November. Forecasters have predicted above normal severe weather for the Atlantic Provinces, so we must remind people to make an extra effort to prepare themselves these occurrences. They should be prepared to deal with the situation on their own for the first 72 hours if help is not available. It they need information on how to prepare themselves they can contact their emergency measures coordinator at the fire station 62 Albion Street or call 902-667-0395.

Councillor Rhindress thanked Council for the opportunity to serve as Departmental Liaison with the Fire Department, and thanked Council for appointing him to the office of Deputy Mayor for the coming year.

Corporate Services Departmental Update

Final tax bills were due on September 28th and statements have now been sent to those with remaining balances as the Department continues to concentrate on collections. Interest has been posted. Files that have tax arrears from past years outstanding, and no arrangements for payment made, will be going to Collection. 4 or 5 properties have been posted for the scheduled Tax Sale on November 27th.

In water billing, letters for payment arrangement for outstanding balances have been sent. Collection effort has been stepped up, and the response has been positive. The next quarter's water meter readings will be finished this month and bills should be in the mail by month end.

More payments via telepayment/telephone or internet banking have been coming in. Many mortgage companies are using EDI payments to deposit their customers' tax payments directly into the Town's bank account, and advising of the transfer by e-mail. Pre-authorized payments have grown as this is a convenient way for the public to handle their tax and water/sewer payments. Councillor Fawthrop thanked the Corporate Services Department for their work and for having been able to be the Liaison officer with that department for the last year.
