"Council took the opportunity to ask some very direct questions of our auditors with respect to the processes and management systems that are in place to monitor and ensure there are no areas with significant risk to the Town. Council remains committed to staying focussed on those issues that remain our priorities.

"In addition, the announcement of our new Director of Recreation, Bill Schurman, is positive for the Town, as it will allow us to expand our focus on economic development by freeing up Roger MacIsaac to spend more time on economic development files and not be stretched thin by handling the recreational issues. In addition, Bill's background has demonstrated that he also will have some input into economic development opportunities, as they relate to his new role with the Town of Amherst.

"In the past year, we have spent considerable time on recruitment and believe that with the hiring of lan Naylor as Chief of our Police Department, Greg Jones as Chief of the Fire Department and now Bill Schurman as our new Director of Recreation, we have a very strong team to meet the future needs of our Town.

"I would also like to take this time to recognize our staff for all their efforts this past year, keeping our budgets in line, as I know it is a team effort to accomplish this. Congratulations Greg and all the staff for doing a great job this past year."
