1.4 Introducing New Members

The Committee welcomed new members, Melissa Johnson and Lynne Welton. Sharon Bristol has sent them documents from the previous meetings to get them acquainted with the committee's mandate.

2. Discussion Items

2.1 Universal Lunch Program

Councillor Jennifer Houghtaling discussed the Universal Lunch Program meeting she attended. This is a pilot project that began on April 11th by the federal government through the province taking place at six schools in Nova Scotia. The hope is to have the program running in all of our schools for the September fall start. They have fresh food carts with locally grown vegetables and fruit available on Tuesdays and Thursdays at those schools. Once the Federal Government finalizes their plan the province will hopefully have for this program for all schools all across Nova Scotia five days a week.

2.2 Round Table Discussion - PRAC Strategy Working Group and Action Items
Sharon Bristol discussed the Poverty Reduction Advisory Committee Strategy,
noting the three main pillars. The following discussion took place:

Food Security

Councillor Houghtaling reported on the initiative taken in Pugwash at the Farmer's Market in partnership with the Pugwash Food bank for market bucks. She will bring back more information at the next meeting. Deputy Mayor Landry suggested perhaps the Committee could look at doing something similar with shop local bucks, perhaps in partnership with the Chamber of Commerce and/or the Business Connector.

Councillor Black noted a program in Oxford where garden beds are provided and seeds donated.

Housing

Sharon noted the work done already with Cornerstone, the Shelter, the YMCA, the PACE program and Low-Income Exemptions.

Youth Outreach and Education

Sharon spoke to the youth center, and gap in services for youth ages 16-25, adding Ruth Currie will be presenting to the Committee in September. The Committee needs to know where the resources are and what the Committee can do to assist.

She also spoke to the Mitacs project undertake by Hallie Tattrie.

Sharon would like to create working groups for these three main pillars. She will email the committee the details and asked that committee members respond with their interest in participating within a week's time so she can schedule meetings and workshops.
